II. Police Department

a. FOP Officer of the Month

The Winter Park Police Department has received this award more times than any other department in the state. IV. New Business


Due the Labor Day Holiday the next Civil Service Meeting will be held on Tuesday, September 9, 2008 at 4:00 p.m.
