MINUTES

1. CALL TO ORDER

Mrs. Clanton called the meeting of the Public Art Advisory Board to order at 12:33 p.m., Commission Chambers City Hall, 401 Park Avenue South, Winter Park, Florida.

2. ART ON THE GREEN

A. FIRST SATURDAYS, ART & MUSIC ON THE GREEN (January 6th and February 3rd)

Mrs. Segal stated at this time waiting for call-backs were the delay. The Board discussed musician's payment if volunteers cannot be initiated and contacting UCF or Winter Park High Band Director for availability.

B. PUBLIC ART FORUM AND RECEPTION

Mrs. Newberg stated the reception will be held at Dr. Robert and Lisa Phelps home at 1316 Green Cove Road, Winter Park on Wednesday, February 7, 2007. Mrs. Clanton suggested that Commissioner Segal read the proclamation for the event.

C. DISTRIBUTION PLAN FOR PRINT MATERIALS

Mrs. Clanton stated the Board has 137 boxes of materials (Art on the Green) that need to be distributed by the end of the exhibition. The Board suggested Farmer's Market, Disney, International Drive (hotels), Community Center, UCF, Rollins, Valencia, the Chamber of Commerce and each Board member. Mrs. Heidrich stated she will organize a plan for distribution of the material/boxes.

Mrs. Clanton stated she will contact Mrs. Swartz along with another person to escort Mr. Accoci to the event.

E. CLOSING EVENTS REVIEW

Mrs. Clanton stated she met with Clarissa Howard and discussed 1) Crealde' School of Art for the children's activities and 2) changing the start time from 12:00 p.m. to 11:00 a.m.

Motion to change the hours of the closing celebration to be from 11:00 a.m. - 4:00 p.m. on Saturday, February 17th. Motion carried with a 9-0 vote.

Mrs. Clanton stated that Mrs. Grey and Mrs. Peterson along with Ms. Hayes assistance will be responsible for hiring a hotdog vendor and suggested a location at the north end of the park. Mrs. Peterson stated drinks, chips, cookies and brownies will be purchased at Publix at the Hollieanna Plaza.

3. ART IN CHAMBERS, JANUARY 2007

Mrs. Petersen stated Mr. Henry Sine was not available at this time. The Board discussed using contemporary art from Jackie Miller or Barbara Sorensen.
